Secure Cash™ is a new, discount prepaid financial service that lets you manage all of your money – have your paycheck direct deposited, pay bills, transfer money – safely and conveniently.

No Traditional Bank Account Required

Because your Secure Cash Visa Prepaid Card account is not tied to a checking or savings account, there are no minimum balance requirements or a credit check required to qualify*. Once your identity is confirmed, we will send you a Secure Cash Visa Prepaid Card, free of charge, which can be used to withdraw cash at thousands of ATMs or purchase goods and services everywhere Visa debit cards are accepted.

Keep More of Your Hard-Earned Money

You won't pay a penny to have your checks direct deposited to your prepaid card account; and once a month you may withdraw cash at an ATM and not be charged a fee. Plus, a fee is not charged to get cash back at participating retailers. Pay all of your bills directly from your Secure Cash Prepaid Card account, and you may never have to buy a money order or pay for postage again! Best of all, you are not charged overdraft fees because you control how much money you put in your prepaid card account each month.

*** IMPORTANT INFORMATION ABOUT PROCEDURES FOR OPENING A NEW CARD ACCOUNT:** To help the government fight the funding of terrorism and money laundering activities, federal law requires all financial institutions to obtain, verify, and record information that identifies each person who opens a Card Account. What this means for you: When you open a Card Account, we will ask for your name, address, date of birth, and other information that will allow us to identify you. We may also ask to see a copy of your driver's license or other identifying documents.

**The Visa Zero Liability policy covers U.S.-issued cards only and does not apply to ATM transactions, PIN transactions not processed by Visa, or certain commercial card transactions.
